

**TERMS AND CONDITIONS**

<b>Organiser</b>	Dutch Lady Milk Industries Berhad ( Registration Number: 196301000165/5063-V)
<b>Name of Promotion</b>	<b>Dutch Lady “Minum Sedap, Menang Mantap” Promotion</b>
<b>Promotion Period</b>	The Promotion starts at 00:00:00 on <b>1 August 2025</b> and closes at 23:59:59 on <b>30 September 2025</b> .
<b>Eligibility</b>	<p>The Promotion is open to all Malaysian citizens and permanent residents in Malaysia aged 18 years and above with valid identification number (MyKad or MyPR) as of 1 August 2025.</p> <p>The following groups of persons shall not be eligible to participate in the Promotion:</p> <ul style="list-style-type: none"> <li>(a) Employees of the Organiser and its group of companies and their immediate family members (spouse, children, parents, siblings, and their spouses);</li> <li>(b) Employees of the Organiser’s agencies associated with the Promotion and their immediate families (spouse, children, parents, siblings, and their spouses).</li> </ul>
